MWPA 2022-23 Projects Overview (MCCABE)

Meg McCabe, FSM's Director of Programming, gave the FSM Board of Directors an update on MWPA Projects, starting with the Adapt Campaign. Current campaign theme focuses on spring yardwork and Fire Smart landscaping. For example, there will be 30, 15, and 6 second videos promoting "spring work" in our yards to get ready for fire season. Todd Lando will narrate the series. For the next series, residents will be taught to "stop the spread of fire." The PSAs will target homeowners in high-risk areas. FSM is currently in production of seven short videos: a) Mythbusters installment regarding myths and risks of eucalyptus trees; b) Adapt Campaign PSA on spring fire prevention work (referenced above); c) Four "Did you Know?" shorts for social media distribution; and d) promotional video regarding Ember Stomp event.

Jen Gauna, FSM's Director of Communications & Outreach, gave an update on social media metrics and statistics for January. She said that social media posting increased to seven days a week, creating 162 individual posts, and accounting for 80,000 impressions across Facebook, Instagram, and Twitter. This is twice the reach seen in December 2022. Also, the FSM e-newsletter template was completely refreshed. In

order to help support countywide preparedness during the recent winter storms, FSM promoted a flooding safety webinar, and collaborated with Ross Valley Fire, Ready Marin, The Town of San Anselmo, and Caltrans.

Meg McCabe told the Board that FSM hired a part-time bilingual staff member, Sarah Dobrovolny. Sarah will be hugely valuable to FSM because she also has much local experience and engagement with our vulnerable communities. Meg also spoke about FSM's Spanish outreach efforts, which have included the following: campaign video production and static ads in Spanish and English; short Spanish messages added to FSM's monthly outreach to community partners; and, Spanish videos added to the enewsletter. She emphasized that FSM works to provide core content in Spanish whenever possible. There was an uptick of viewers of Spanish content on FSM's YouTube channel. Ember Stomp Update

Rich Shortall told the board that the *Ember Stomp* event on Saturday, May 20th (11 to 5) will be "bigger and better" than last year's inaugural event. A couple examples are the planned Live Burn demonstration and three Fire Smart landscape spaces (over 420 square feet) showing aspirational yards that are not only fire safe, but functional and beautiful, too. A wildfire related Art Exhibit, "New Frontiers Stage" showcasing new technologies, products, and innovative solutions at the forefront of wildfire science, expanded kid's area, food trucks, and bands are just some of the planned activities. Rich is hoping with the larger and better spaces available for vendors and exhibitors, that the fire agencies will come out to exhibit and engage and to showcase their work. Promotions and advertising will begin in late March. Rich asked if anyone would like to participate in planning or volunteering during the event to please contact staff at info@firesafemarin.org.

NorCal Landscape & Nursery Show Overview

Rich Shortall, FSM's Executive Director, told the Board that he gave a presentation at the NorCal Landscape & Nursery Show in San Mateo on February 9, 2023. This show was operated by the Nor Cal Nursery Group and the California Landscape Contractors Association. There were many breakout sections and exhibits. His presentation focused on the role embers play in home destruction. It addressed what landscapers can do to reduce the threat of embers, for example, proper maintenance, horizontal and vertical spacing of plants, use of hardscape in landscape design, proper choices of mulches, fire resistant plant selection, and removal of highly flammable plants (special attention to "Zone 0" within five feet of the home). Rich's experience at the conference confirmed the need for FSM to work as much as possible with the landscape community. Landscapers showed high interest in learning best practices.

Wildfire Resilient Structures Conference Overview

Jen Gauna and **Meg McCabe** attended the UC Davis Inaugural *Wildfire Resilient Structures Conference & Tradeshow* in San Diego on February 7-10, 2023. This event addressed the WUI fire risk for the built environment. It drew both public and private

audiences, such as researchers, scientists, fire safe councils, insurance industry and commercial companies.
