#### **Project Summary/Description**


This project was identified through partnership between FIRESafe MARIN, Marin County Open Space District, and Mill Valley Fire Department staff. Marlin Avenue is located in a designated wildland-urban interface (WUI) zone. The area between 100-150 Marlin Avenue consists of multiple single family homes adjacent to a 3.4-acre open space parcel containing several dead/dying Monterey pine trees as well as combustible, dead vegetative material on the ground. Residents have expressed concern regarding the amount of dead/dying pine trees and would like to see them removed. The trees increase the fire hazard to the residents in the vicinity of powerlines. Roughly half of the area is within the 100-foot defensible space zone of nearby homes, and is adjacent to the Marlin Fire Road. The project removed approximately 30 pine trees in various stages of life from saplings to standing dead and/or dying trees.
