Project Summary/Description

Corte Madera Fire Department, in cooperation with FIRESafe MARIN, identified a section of Meadowsweet Drive from Lupine Drive down to Meadowcrest Drive, and Chapman Drive, in the Chapman Park hillside neighborhood where roadside vegetation threatens safe ingress and egress during a wildfire. The work area was about one mile long, with multiple sections where trees and branches overhang the roadway made it difficult for Fire Apparatus to travel. In several areas, dead vegetation in the right-of-way extended well into the street. Fire Department personnel had reported that fire engines must travel down the center of the street to avoid overhanging branches.



This project focused on vegetation clearance along the roadway, to improve overhead clearance and reduce fuel loads along the sides of the road, to reduce the risk of flame impingement on the roadway in the event of a wildfire. Corte Madera Fire Department personnel, and FIRESafe MARIN, directed a landscape contractor, Forster & Kroeger Associates, on specific locations for vegetation removal. Approximately 14 tons of material was removed.

Work was conducted between August 14 and 28, 2017.
